KRI Field Updates









Departures

- During the month of September, a total of 133 households, 159 individuals from Duhok camps returned to Sinjar center, Shuhada, and villages around Sinjar namely Tel Qasab Tel Binat, and Tel Zer.
- Family reunions and employment opportunities were among the primary pull factors cited by the returnees.

Irregular movement of Yezidi IDPs to Europe

- 1,861 Yazidi individuals recorded crossing Ibrahim Al-Khalil from August to September 2022.
- The major reasons for departures include the poor socioeconomic conditions of Yezidi IDPs in areas of displacement, particularly in camps; and a general sense of despondency and lack of solutions among IDPs, as well as the inability of Yezidi IDPs to return to areas of origin due to the security situation.





- Since January 2021 and Up to 20 October 2022, DMCR has received 1166 requests from families who want to re-admit to Dahuk. Out of 1108 families, 1015 were interviewed, 1005 families received approval to access to Dahuk, and 356 families /1.747 individuals were re-admitted to Dahuk camps.
- Sinuni and Khana Sur have the highest proportion of returnees, due to the following:-
- o The presence of several armed groups and the overall instability in the area were listed as the primary reasons for returning.
- o Inadequate Basic services in Sinjar and Sunni cities.
- o Limited access to employment opportunities in Sunni and Sinjar centers.







East-Mosul Camps

The EMCs are experiencing steadily growing numbers of IDP departures mainly due to prevailing humanitarian conditions. In September, a total of 36 households, and 253 individuals returned to areas of Origin where the main destinations of return were highlighted as Ninewa and its vicinity, including Hamam Al-Alil, Tal Afar, East, and West Mosul. As shown below.

The issuance of departure letters by MoMD has been suspended in the IDP camps, which
particularly affects the IDPs in EMCs. Nonetheless, advocacy efforts are underway through
protection partners.







Debaga Camp

In September, 9 families in total departed the camp. The family came from Makhmour, Qaraj, Markaz Mosul, and Qayyarah. With the exception of one family, who returned to Makhmour, the rest were relocated to Kirkuk and Erbil. The emphasized push factors were a lack of adequate humanitarian assistance.

Baharka & Harsham Camps

- Throughout September, 10 households of 52 individuals departed Baherka Camps., 6 of which were relocated to Erbil urban areas, while only 4 households returned to their hometowns in Baaj. The proximity of livelihood opportunities was cited as a key pull factor.
- During the reporting period, movement/departures in the Harsham camp remained relatively stable.



Sulaymaniyah Camps



 During the months of September and October, a total of 34 families left the Sulaymaniyah and Garmian camps and returned to their origin areas, as shown below.

Camp consolidation initiatives

On October 18, following the visit from humanitarian actors and the government representatives and holding the conference with camp residents, seven families and 34 individuals from Qoratu left the area and returned to the Diyala-Saadiyah Subdistrict. No formal discussions have yet been held with the authorities regarding the IDP camps in Ashti and Arbat.







Supreme Committee Decisions





- Local Integration
- Resolution 888 (Supreme Committee for the relief and Support of the Displaced)
 - Assign MoMD to close the files of IDPs who are not willing to return and prefer to remain in areas of displacement and integrate into the society in accordance with directions of GOI to find appropriate solutions for them.
 - Data base to be created for IDPs wanting to locally integrate.
- Progress to date: Developments in Diyala---approval by the government of Diyala, reportedly approvals in Kirkuk, Kerbala and Baghdad, still to be confirmed for other regions
