National DSTWG Updates





• Transition:

- Joint Transition Paper (Option 6) MOMD welcomed plan for joint transition paper (RCO, UNDP, IOM). Next steps is for transition WG to meet and begin drafting process
- **Discussion:** Light Strategy Paper (Opt2), OCHA and Joint Transition Paper (Opt6) to be both further developed: Opt2 paper is short-term (Hum priorities focused) and Gov to take-over; Opt6 paper is long-term (DS and moving ahead towards Dev)
- NPC and DSTWG joint workshops 'centrality of protection in working towards durable solutions' planned for Dec 4-8 in Diyala, SAD, Anbar, Kirkuk and Ninewa.
- GP 2.0 Analysis of DS in Iraq (Case Study):
 - G.P 2.0 conducts a global analysis on DS mechanism in context of cluster deactivation to inform countries where DS coordination structures exist or where they are being considered. (Interviews with DSTWG, DTSF, ABC FPs, donors, NGOs etc). Expected output is a short report capturing current situation & recommendations.



Timeline : November-January 2023 (Round table with authorities, community consultations, drafting and final review)


Government Engagement
