

Transition – 2023 Humanitarian Response Strategy

Transition – 2023 Draft Humanitarian Response Strategy



OCHA June Options for 2023 Response Planning provided the following:

- Option 1: No Response Plan or Strategy
- Option 2: Light Strategy Paper
- Option 3: Extension of 2022 HNO and HRP into 2023
- Option 4: Limited HNO and HRP for 2023
- Option 5: Full HNO and HRP
- o Option 6: Joint Humanitarian-Development-Government Transition Plan

Option 2: Light Strategy

Would set out the main need that the government and development partners are not expected to be able to cover for 2023 and define the HCT's recommended priorities for humanitarian actors and donors. This would help donors and agencies to prioritize support for 2023 after clusters have deactivated.
