Establishing Agreement with Government of Iraq

25 October – Joint workshop with Government of Iraq

Interim period focused on engagement on substance of the agreement and resolving issues on data points

- 8 November Supreme Committee endorsement of document (in principle)
- Next steps: final inputs from Government ministries (including KRG) and preparation of launch (provisionally 23 January)

# JCF Update and Co-Chairs endorsement



#### Progress in JCF Establishment



- The COMSEC letter to establish JCF has been issued and delivered to the respective governorates.
- Then; The RC has sent letters to the governors' offices to introduce the co-chairs and the secretariat of JCF and to urge the arrangement of inaugural meetings, who will co-chair.
- Authority Action: Administrative Orders have been issued in Diyala, Kirkuk, and Basrah, formalizing the establishment of the JCF. Progress is ongoing in other governorates.
- The inaugural meetings have been tentatively identified in some governorates SAD (26<sup>th</sup> Dec.), Kirkuk (27<sup>th</sup> Dec.), Diyalah (Jan 04<sup>th</sup>) and Basrah (Jan 11<sup>th</sup>)
- Agency Interests in Co-Chair Roles and Memberships have been shared with RCO Proposed Co-Chair Agencies for the DSTF Endorsement:
  - Basrah and Ninewa: UNICEF
  - Diyalah and Anbar: IOM
  - KRI: UNHCR
  - Kirkuk : IRC
  - Salah Al-Din: RCO, temporarily, until further expressions of interest are received.
