



DTM Methodology

DTM Methodology



- Key informants provide a count of IDP and returnee households
 - Definition IDPs: all Iraqis who displaced since January 1, 2014 and have not returned to their location of origin, as well as those who did return but have since re-displaced. This includes <u>ISIL- and climate-related</u> displacements.
 - Definition returnees: all IDPs who have returned to their location of origin, regardless of whether they returned to their former place of residence or to another type of shelter.


Provides <u>systematic monitoring of displacement movements</u>, <u>drivers and vulnerabilities across locations</u></u>. Produces keystone displacement figures for Iraq response, previously for HNO and HRP, and is used across programmatic, strategic, and advocacy workstreams

Methodology deployed globally in line with International Recommendations on IDP Statistics (IRIS), Joint Intersectoral Analysis Framework (JIAF), IASC Operational Guidance on Data Responsibility in Humanitarian Action, and other relevant frameworks





- Certain findings may be under-reported or over-reported, due to the subjectivity of key informants (despite quality assurance measures)
- IDPs who may have <u>locally integrated or settled in a third location</u> are still be considered as IDPs, whether or not they have achieved a durable solution; however, new methods piloted to fill evidence gap



MoMD Methodology



- Starting in the winter of 2013, MoMD created a biometric system to register IDPs for <u>case</u> <u>management</u>. IDP registration closed in 2018
 - Registration to receive government support (grant and in-kind); Displacement card issued
 - IDPs defined as a household that has registered
- In 2018, MOMD started the process of registering returnee families, exclusively for families who displaced prior to this date and have a displacement card
 - Registration to receive government support (grant and in-kind) for up to 1 year
 - Returnee households defined as a household that has closed their IDP file/registered as returnee
- Recent developments: In November 2022, MoMD announced efforts to start local integration/relocation registration. In early 2023, MoMD started registering these families in southern governorates. MoMD have also developed a separate dataset for climate displacements.







Positive, ongoing discussions with MoMD and DTM on methodological approaches. Potential discrepancies identified so far:


Some families may have returned to their locations of origin without closing their IDP file

• MOMD classifies them IDPs, while DTM considers them returnees through the

Some families who were displaced and then returned <u>did not register at all</u> with MOMD, for example due to intra-governorate displacement or displacements that happened after the registration process closed in 2018

• DTM considers these families returnees after their return to their areas of origin, whereas MOMD haven't included them in the caseload. DTM also tracks displacements post-2018 (ex. failed returns and secondary displacement)

DTM counts newly formed households (ex. Marriage) not reflected in MoMD data

Different and parallel methodologies, for different purposes



Discrepancies may be related to returnees who have not yet closed their file, households who never registered, or newly formed households



Total caseload is similar

Looking ahead


With reorientation around the evolving context, so too must the evidence base adapt.

- Determining how to <u>measure progress</u> along solutions pathways and <u>priority setting</u> amongst caseload
- What are living conditions of IDPs and returnees compared to people who never displaced from those areas? How to target and support last-mile caseload?

DTM's Displacement and Return Indexes – location-level vulnerability analysis – durable solutions planning tool DTM's Progress Toward Durable Solutions project

- Household-level survey of returnees, IDPs, stayees
- Piloted in Ninewa expanded to Salah al-Din
 - Low, medium, high progress groups for IDPs and Returnees, based on IASC DS Framework and DSID
