KRI Field Updates







- May 2023, 554 households and 1218 individuals.
- June 2023, 470 households and 2313 individuals.
- The returns were to Sinjar and villages nearby.

Reasons for return:

- IOM FVM program
- Reuniting with their families and relatives
- Security situation improved

Reverse Return:

- May 2023, 8 households and 35 individuals
- June 2023, 1 Individual





Hassansham U2 Camp:

- May: 9 households 54 individuals
- June: 16 households 91 individuals
- Most returns were to Makhmour, Shirqat, Talaafar and Ninawa.

Hassansham U3 Camp:

- May: 11 households 49 individuals returned to Kirkuk, Ninawa and Tlkif.
- June: 17 households 91 individuals returned to Mosul, Kirkuk and Talaafar.

Khazir Camp:

- May: 33 households 176 individuals returned to Ninawa and Tkrit.
- June: 22 households 118 individuals returned to Ninawa.





Debaga Camp:

- May: 13 households 74 individuals
- June: 11 households 62 individuals
- Most returns were to Gayara, Makhmour, Hawija and Kirkuk

Baharka Camp:

- May: 2 households 9 individuals returned to Bahrka, Gazna and Tlkif.
- June: 4 households 27 individuals returned to Baaj and Harsham.

Harsham Camp:

- May. 3 households 16 individuals returned to Ninawa.
- June: 6 households 28 individuals returned to Ninawa and Zakho.





May and June

- *Qoratoo Camp*: 2 households and 11 individuals returned to Al Muqdadiya, Diyala.
- Ashti Camp: 10 households and 45 individuals returned to Balad, Salah Al-Din
- Arbat and Tazade camps witnessed no returns.

Out of Camp:

• In May and June 499 households returned to Salah el-din mainly Ajeliyah and Canal 34 were used to be areas of no return

Reverse Return:

• No reverse return cases.





May and June

- 3 households returned from Kirkuk to Hawija- Riyad substrict (Al- Safra Village).
- 6 households returned to Hawija- Riyad substrict (Tar Al- Baghal Village).
- No returns are scheduled for Daquq and Dibis districts yet.

Key Notes:

- The Housing and Property Compensation Committee is actively working on completing the necessary procedures.
- Currently waiting on the allocation of financial resources to facilitate the next steps.
- No compensation grants have been provided in the last two months.











- 57 Families, 309 Individuals returned from Sharya Camp to Markaz Sinjar, Jazeera complex
- During June 2023 many families returned from different areas in Kurdistan:
 - 42 HH return to Sinuni sub district and 31 HH return to Sinjar center, Tal Qassab and Tal Banat villages.





• 40 HHs returned to Telafar from southern areas in Iraq to Khadraa, Qalaa and Mualemeen neighborhoods.

Returns from Turkey

• 12 HHs returned from Turkey to Markaz Tel Afar on different dates.





- On 13 June 89 HHs, 440 Ind. returned to Tel Ozer, Qahtaniya Baaj from Sahrya Camp.
- On 16 June, Ninewa Governor visited Al Qahtaneya Sub district
- 90 Families expressed their will to return To Khwetla Khamsa in Baaj from Makhmoor Camp if the financial support.
- 49 HHs return to Tal Ezer/Baaj on their own from different locations in Kurdistan





- By the end of 2022, more than 200 B IQD was distributed to more than 18,500 cases in Ninewa.
- 4 B IQD was distributed in 2023.
- 2 B IQD was added in 2023, serving more than 370 cases.
- The department is expecting more funding once the national budget is fully approved and activated.
- The department is still receiving new applications in 2023.
- It has been announced that there will a special fund for the compensation file for Sinjar district, but there is nothing yet. And because the Sinjar inhabitants delayed applying for the compensation, therefore, they will be delayed in receiving it.

Voluntary Returns:

- 44 HHs returned from Jedah1 camp to AoO in SAD on 30th May.
- 150 HHs returned to AI-Ajeleah village and Canal 34 on 1st June. Total number of HHs in camps 800, 250 in Arbad, 550 in Ashty.
- 59 HHs returned from AAF camps to AoO according to IOM facilitated voluntary movement: 18 families to AAF district,
- 13 HHs to Karma district, 12 HHs to Fallujah district, 4 HHs to Ramadi district, 11 HHs to Qaim district.
- 13 HHs return to Heet, Haditha, Qaim, and Rumana in May.
- 2 HHS return from J1 to Haditha in May .
- 3 HHs returns to Baghdadi sub-district in June.
- Expected returns to 17 locations in Al-Saadiya in Diyala supported by local authority, no action on the ground.
- 139 HHs returned to Iskandaria subdistrict in Babylon since 2017, including 22 in 2023.





• MoMD announced the return of (102) Iraqis from the areas located on the Turkish-Syrian border to the country by land and through the Ibrahim Al-Khalil crossing of Zakho district in Dohuk Governorate, and then to their original areas in the governorates (Ninawa, Salah al-Din and Anbar), after completing their entry procedures.





- SAD government has gotten all approvals from the security agencies to move the 55 families from Al-Mu'sakarat camp to the low-cost camp in the district of Alam in the SAD.
- The eviction are supposed to be carried out end of the July or August.
- Ministry of Defense is supposed to take the location to accommodate the 21th division of the Iraqi Army.
- IDPs are facing political, security, livelihood and housing challenges to return to their AoOs, mostly Kirkuk and SAD.
