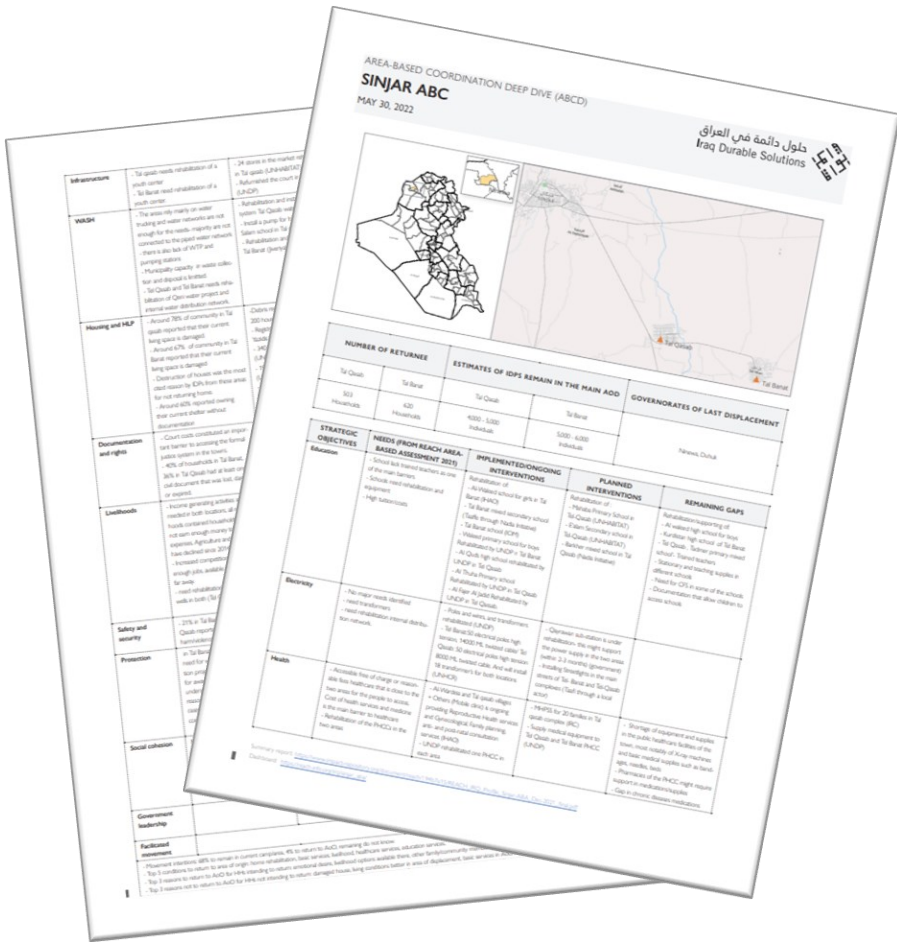
ABC Update – PoA Revision

Round Table & Community Consultation Update:

- **Kirkuk:** RT meeting scheduled for **February 1**. Presentations and discussions will cover Hawiga PoA revision and the initial PoA of Debas and Daquq. The required data collected, and CC sessions are starting soon.
- **Salah Al-Din:** RT meeting scheduled for **January 22**. Data collection and CC sessions are ongoing.
- **West Anbar:** Roundtable meeting with local authorities scheduled for **January 17**, while community consultations are currently ongoing
- **East Anbar:** Roundtable meeting date **TBC**, while community consultations are underway
- **Baa'j:** **Meet on 15 Jan** re POA revision (roundtable, community consultations, assign responsibilities + discuss upcoming deep dive (Rambousi followed by Qahtaniya)
- **Diyala:** **Meet on 11 Jan** with Gov officials for Jalawla and Sadiya on location profiling, needs, priorities, and current activities followed by a separate meeting on round table, community consultation and POA timeframe for the revision
