RWG conducted meeting with Babil deputy governor and MoMD in August

Key points:

- Challenges and needs for the returnees: **infrastructure, livelihood, services**(281 families)
- Potentials to open blocked villages to return remaining IDPs (1270 families).
- Future cooperation between **aid community and local government** to provide durable solutions.
- Next activities: **Dialogue session with community, DS discussion** with government, local government, security, and community.

## Return Updates – Diyala

- 250-300 families from different AoO in Diyala have registered for integration in Khanaqeen.
- 470 families are planned to return to Al-Khilani village on Tuesday, 24<sup>th</sup> of Sept.

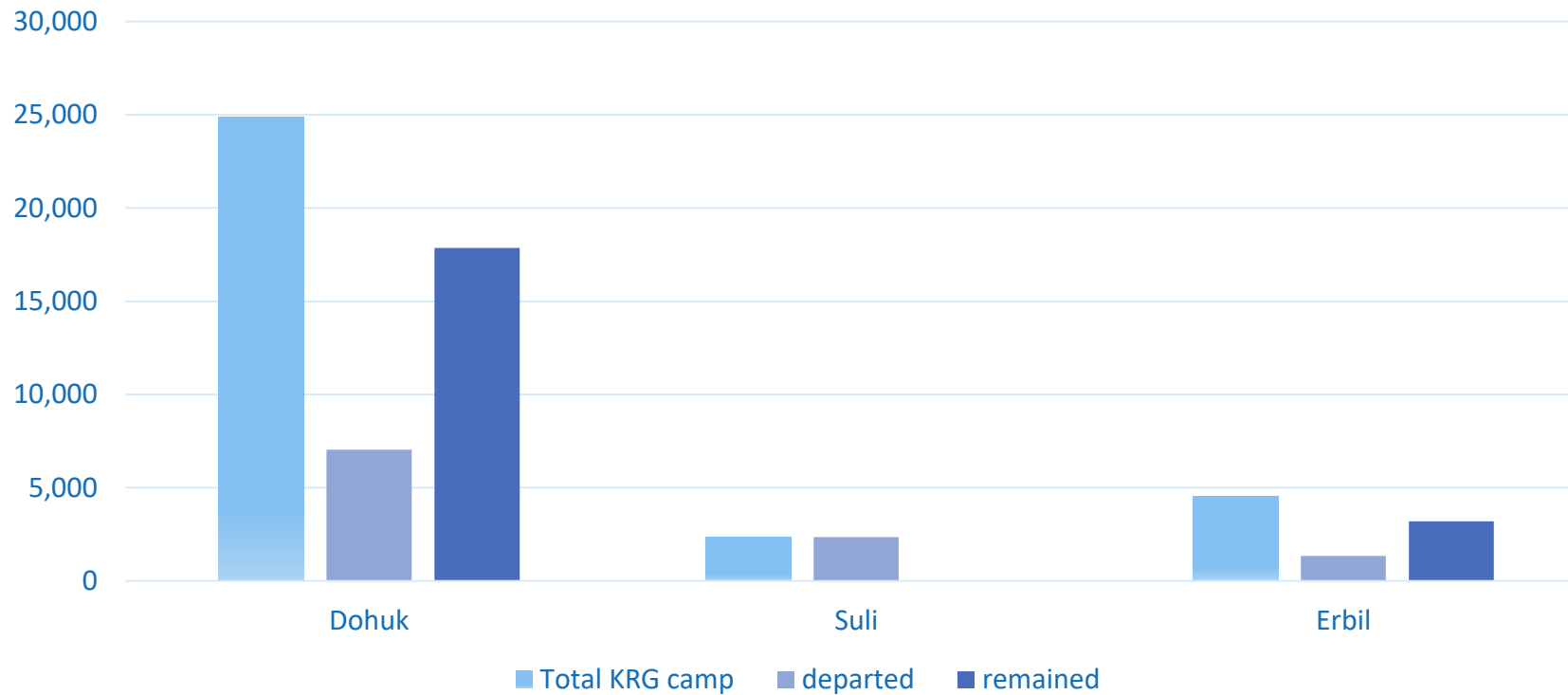

Total departed from KRG camps: According to DTM 80% returned to AoO, while 20% either re-integration or relocation

## Anbar Blocked Area Akashat

### Akashat (Anbar)

Led by deputy governor, agreement by the PMU to reopen the area.

Local government authorities have conducted an assessment of the area and needs. Next step will be an interagency visit which the involvement of the Anbar JCF.



# Akashat

Assessment has been conducted by governmental committee:

## **Municipalities Sector**

Construction of the municipal department building in the residential complex

## **Health Sector**

Demolition and reconstruction of Akashat Health Center

## **Education Sector**

- Resumption of work on the construction project (12-grade school in Akashat Complex) (15% completion rate approximately) under the supervision of (Anwar Al-Sadil General Contracting Company), noting that the financial allocations for the project are available
- Demolition and reconstruction of:
  - Akashat Mixed Secondary School 12 grades
  - Akashat Elementary School for Boys
  - Akashat Elementary School for Girls

## **Sewerage Sector**

Rehabilitation of the treatment unit and equipping it with pumps with ownership of the sewage network

## **Electricity Sector**

Rehabilitation of the internal network of Akashat Complex, noting that the network is designed in an under-ground manner

## **Water Sector**

Rehabilitation of wells in the Makr Al-Dheeb area and nearby wells in the area with the transmission line to the residential complex,

## **Communications and Information Complex, Al-Rutba**

Rehabilitation of the communications network for the complex

## **Security headquarters**

Demolition and reconstruction of the police station.

# Sulaimaniyah Governorate



## IDPs return

In the past two months, a total of 286 IDP families returned from Sulaimaniyah governorate to their areas of origin. In July, 219 families made their journey back, followed by 67 families in August (out of camp). The majority of these returning families have resettled in Salah El-Din governorate

### Reason of return

- Many IDP families have returned to Sinjar after receiving positive reports from relatives and neighbors about improved security and an increased population in the area.
- The MoMD grant.
- The prospect of finding work in their original occupations and the desire to reunite with family and friends are major motivators for returning.



# Kirkuk

# Kirkuk Governorate



5 households from the Kirkuk center returned to the Al-Hawiga district .

- 2 households returned to the Al-Abbasey subdistrict.
- 2 households returned to the Al-Zab subdistrict.
- 1 household returned to Markaz Hawija.

The Housing and Property Compensation Committee is actively working on completing the necessary procedures and the compensation amounts have been delivered to 70 families during the past month (August).

# Kirkuk Governorate



A DS discussion will address the protracted displacement of families in three villages in the Dabes District, focusing on obstacles like landmines, destroyed infrastructure, and families' perceived affiliation with ISIL. The aim is to facilitate collaboration between local authorities, NGOs, and displaced communities to find practical solutions for their return or relocation, restore essential services, and address the needs of those who can't return

# Lower Returns to Ninewa

## MoMD Registration Process Halted

- Halted since 12 July 2024
- Families are unable to register for return and those who registered prior to 12 July are being assisted to return.
- Lack of information to IDPs from MoMD on extension of the camp closure deadline and disbursement of the grant.
- More returnee families are reporting more delays in receiving the grant.

## MoMD Aid packages in Ninewa

- MoMD Branch in Sinjar distributed the following items to returnees:
  - 750 refrigerators
  - Televisions
  - Kitchen Tools
  - IQD4 Million to 700 camp returnee families

# Hate Speech Incident

## On 3 August 2024

- Statements from Qassim Shasho caused widespread outrage in KRI and Ninewa
- Surge in hate speech against the Yazidi community on social media
- Prompted an estimated 500-800 IDP HH to flee to Sinjar.
- Many returned to Dahuk soon after the while a few remained in Sinjar.
- OCHA led a fact-finding mission with the Sinjar ABC which found that it was unclear if the families had returned due to the hate speech or due to the camp closure announcement.
- Some humanitarian needs were identified for Bahloul Village.



## Area of No Return Islopy Village, Hatra

### Slopy Village

- Hatra has the highest number of locations of no return in the country and in Ninewa with **54 locations**.
- On 9 September the RWG facilitated a DS discussion with the Ninewa Local authorities to address the obstacles to return.
- Key concerns were:
- Housing destruction of mud houses
- Access to services, water, electricity, schools
- Presence of PMF in the village
- Families expressed the intention to return
- Concerns will be raised to Ninewa JCF



# Sinjar ABC and Ninewa JCF

## Sinjar ABC

- Mine action activities (August)
- Continues to meet at Sunrise NGO in Sinjar
- Outcome of Sinjar Fact Finding Mission
- Situation of Tal Bahloul Village
- Call for NGO co-chair for the ABC

## Ninewa JCF

- IDP situation in Dahuk
- 19,305 HH in camps and 37,000 HH outside of camps
- Concerns around IDP reluctance to return during school term
- Deputy Governor of Planning---29 Projects in West Ninewa, IQD18,5 Billion
- Director of Municipalities---Qahtaniyah, Adnaniyah, Al Jazirek, Tal Qasab and Tal Banat as priority areas



# Ninewa Compensation Update

## Compensation Committee (Sinjar)

- Total Files Approved: 3,150
- Families who received payments: 287

## Challenges:

- Delay of payment
