

Minutes of the Mosul ABC Meeting

16 May 2023, 10:30 – 12:00

Objective:

Discussion of the J5 closure response coordination - updates from partners, highlights of current gaps observed, NRC - presentation on Protection Service Mapping, ACF- presentation on Public Distribution System gaps.

Main Points:

The IOM FP welcomed the attendees and started the instruction and the meeting started with: -

- OCHA briefed on the inter-agencies mission to Qayyarah to follow up on the issues of the J5 camp that closed suddenly. The mission started by meeting with the mayor of Qayyarah, and then the mission conducted FGD with the IDPs who are living in tents around the fence after J5 closed. The families are unable to reach the services such as water, electricity, food, health, and WASH. Neither the government nor the partners have any activities to provide the mentioned services although some partners conducted some assessments. The government has given the families a strict 60 days' time frame to leave the location and return to their area of origin. families More details are in the attached OCHA report.
Nonviolent Peaceforce provided more information on the Hawashim secondary displacement site as in the attachment.
IOM legal team started the discussion with the government of Qayyarah to register the 200m² of land that most of the families already bought in the Al-Hawissm village and to get the government approval to reside these families in the village.
- NRC presented on the NRC protection in Mosul. The presentation briefed about the strategy over the culture which was 1) Protection analysis. 2) Qualitative service maps. 3) Participation in coordination.
Compelling cases was included the Families of perceived affiliation, various group, and experiences, and tailored and diversified approach. The activities covered Hay al tanak, Tal al-Roman, and Intisar. The social workers provided case management, follow up the needs and referral and some cash assistance.
