Objective:

Discussion of the Hawashim secondary displacement site and the Update from the Government of Ninawa on the returnees from J1.

Main Points:

The new IOM FP welcomed the attendees, and after the introduction the meeting started with: -

- Following up on the action points from the previous meeting: -
 - For ICF to share the final report of accessing social protection in Iraq because no one from ICF attends the meeting, therefore, this action point is ongoing.
 - For IOM the legal team to follow up with the mayor's office to get the approval to reside these families in the village with the land registration. Done
- Mr. Khalid Abdul-Kareem the Ministry of Displacement and Migration (MODM) Director of the Ninawa branch appreciated the participants and started the discussion on the returnees from J1 to all areas of origin in Ninawa and other governorates. Mr. Khalid confirmed that the MODM has all the information of the returnees including names, phone numbers, locations, and the type of support needed. Mr. Khalid emphasized that the priorities needed are legal support documentation, MHPSS, livelihoods, and social cohesion. Mr. Khalid confirmed that MODM is seeking for coordination mechanism with the partners to provide the mentioned needs to the returnees and the MODM is ready to share the required information on the returnees after receiving an email from the partners requesting this information, and the partners should provide feedback on their response during one week to the MODM. It has been agreed that MODM will share the number of the returnees, their location, and the type of support needed with the Mosul ABC secretariate.

Mr. Khalid briefed that he conducted meetings with the mayor of Qayyarah, security forces, and the mukhtar of the Hawashim, and the outcome of these meetings is that the IDPs in Hawashim can reside as long as they want because Mr. Khalid clarified to the Mayor, SF, and the Mukhtar that those IDPs they have the right to reside there, and they obtained the security check.

Action Points

- For ICF to share the final report of accessing social protection in Iraq, mapping of programs, and analysis of barres with the Mosul ABC group.
- For the Ninawa MODM to share the number of the returnees from J1, their locations, and the type of support needed with the Mosul ABC secretariat.
- For the Mosul ABC secretariate to share the list of the returnees and their needs with the partners, and for the partners who can respond to the needs to inform the Mosul ABC secretariate, and to be shared with MODM.
- For the Mosul ABC secretariat to share the contact information of Mr. Khalid with the ABC secretariates in the other governorates (Kirkuk, Diyala, Anbar, and Salah al-Din) to get more information on the returnees from J1 to their governorates.
