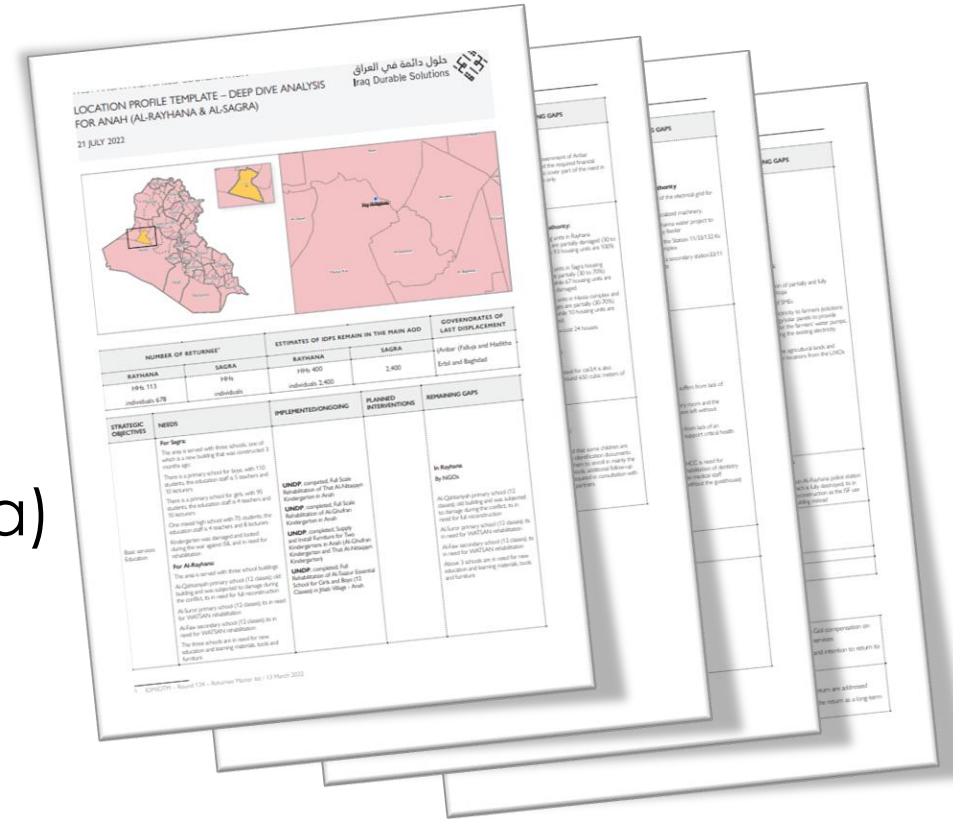

Overview of the Compact

- Proposed strategy of engagement with the Government of Iraq, Kurdish Regional Government and UN + to address the ‘last mile challenge’
- Joint effort between the DSTF and the UN Office of the Special Advisor to Solutions
- Initial inception phase [Jan/Feb]: 5 March Concept Note proposes 13 areas of engagement with the Government of Iraq.
- The focus of the Compact is on high level structural engagement with the Government(s), complimenting the DS programmatic work.

Compact preparation phase

- Drafting group established on 26 March: includes IOM, UNDP, UNHCR, WHO, UNICEF, ILO, NRC, WFP and DSTWG
- Analysis of the technical components of the commitment and Data Preparation (REACH/DTM)
- Drafting group was established on 26 March: includes UNDP, IOM, UNHCR, WFP, WHO, UNICEF, ILO, NRC and DSTWG
- Initial discussions with coordination platforms including Protection Platform and NCCI
- Soft engagement with the Government of Iraq and Kurdish Regional Government

Next Steps

- Conclude the initial drafting phase of the compact commitments by 20 April to share with DSTF co-chairs and DSRS
- Initial data analysis exercise to be conducted by mid May
- Launch formal process with the Government of Iraq and Kurdish Regional Government
