# Climate Displacement and Environmental Needs

#### Recent trends

- Drought displacement in Qayyarah, Hatra and Ba'aj
- Need for data collection and air monitoring
- Proposal for IQD1,2 billion for mobile stations



### Ninewa Governorate Consultation on Funding Challenges



### **Challenges Raised**

- Reliance on aid actors/organizations
- Limited technical capacity to fill gaps
- Risks of prolonged displacement or re-displacement



## **Key Gaps & Recommendations**

- Housing Rehabilitation
- Access to sustainable livelihoods
- Infrastructure/basic services
- Legal Aid
- Report to be submitted to GOI and shared with diplomatic missions
- Need for transition plan

### Status of IDP Committee

### **Committee Membership**

- KRG---Minister of Interior Advisor and Director General of JCCC
- GOI---Ministry of Migration and Displacement, Representative of the Prime Minister's Office
- National Security Advisory

#### Mandate

- Established in August 2024
- Facilitation of formal return procedures for camp based IDPs
- Validate and process return application in coordination with MoMD
- Dignified return of IDPs, monitored by the aid community

#### **Status**

Not activated pending final approval by MoMD and Prime Minister Office
